Approval of the rules of procedure of the assessment panel

1. I announce an open design competition for a two-euro commemorative coin for the Finno-Ugric peoples, and approve the rules and regulations for the competition (Appendix 1) and the rules of procedure of the panel (Appendix 2).
2. The General Secretariat shall publish in the media Eesti Pank's announcement of the design competition for the two-euro commemorative coin together with the rules and regulations of the design competition.

## **Two-euro commemorative coin for the Finno-Ugric peoples**

### **Rules for the design competition**

#### **1. Purpose of the design competition**

The purpose of the design competition for the specially designed two-euro coin, or commemorative coin, dedicated to the Finno-Ugric peoples is to find a design for the national side of the coin. The design of the common side of the coin is not changed.

#### **2. Conditions of the design competition**

- 2.1. Any person wishing to participate in the design competition may do so individually or in a group.
- 2.2. Entrants to the competition may submit one or more designs for the national side of the commemorative coin.
- 2.3. The deadline for the submission of designs is 30 April 2020 at 12.00. Designs submitted after the deadline will not be entered in the competition.
- 2.4. Designs should be submitted by the deadline in a sealed envelope to: Mündižürri (Soome-ugri), Eesti Pank, Estonia pst 13, 15095 Tallinn.
- 2.5. Each design must be submitted on a separate page and given a one-word title. If a designer submits multiple designs, each design must have a separate title. Each design must be accompanied by a sealed envelope containing the designer's details: name, address, telephone number and email address, bank account number, and the registry number if the designer is a FIE. The sealed envelope should be marked only with the same keyword as the design.
- 2.6. Participants in the competition confirm by submitting the design that the design is original and does not breach the intellectual property rights of any other party.
- 2.7. The winner of the coin design competition will be paid 2000 (two thousand) euros as a prize within ten calendar days after the commemorative coins have been issued. The designer of the second-placed design will get 700 (seven hundred) euros and the designer of the third-placed design will get 500 (five hundred) euros ten calendar days after signing the contract detailed in point 2.9.
- 2.8. All legally required taxes and payments will be deducted by Eesti Pank from the amounts listed in point 2.7.
- 2.9. The competition winners and the second and third placed entrants will sign a contract granting all the proprietary rights of the design to Eesti Pank, giving exclusive permission to exercise the licensed personal proprietary rights of the designer insofar as this is necessary for the minting of the coin and making related products. The designer grants Eesti Pank the right to sub-license the licensed rights without limit of time or place. The contract will be signed once the results of the competition have been announced, and it must be done before the prize can be paid to the designer.

- 2.10. The panel judging the competition has the right to propose additions to the winning design or changes to its proportions and composition.
- 2.11. The winning designer or group of designers will make the changes proposed by the panel or the minter to the design immediately and for no additional fee and will then present the amended design to Eesti Pank within ten calendar days of receiving the proposal for the changes.
- 2.12. If the winning designer or group of designers does not immediately make the changes proposed by the panel or the minter to the design for any reason, and refuses to grant Eesti Pank or a third party nominated by Eesti Pank the right to make such changes, then Eesti Pank will have the right to mint the coin using the second-placed design in the competition. In this case the winning designer will not receive any payment and no contract will be signed with them.
- 2.13. If they want to, the winning designer may design the six-sided presentation card for the coin, which will have the dimensions approximately 90 mm × 140 mm and will meet the Eesti Pank requirements for compulsory elements; this will be covered by the fee stated in point 2.7. If the winning designer is to design the presentation card, they must do so within 30 (thirty) calendar days of signing the contract referred to in point 2.9. The intellectual property rights of the design for the coin card will in this case be regulated under the contract referred to in point 2.9 and under the same conditions.
- 2.14. The winning designer or group of designers will make or allow to have made a plaster or other three-dimensional model of the coin for minting within 14 (fourteen) calendar days of signing the contract detailed in point 2.15. Where needed, the winning designer or group of designers will consult Eesti Pank during the preparations for minting and visit the mint to assess the various stages of the preparations.
- 2.15. The winning designer or group of designers will sign a service contract for preparing the plaster model or the plaster and 3D models and for visiting the mint. Eesti Pank will pay up to 1200 (one thousand two hundred) euros of costs for making the plaster or other three-dimensional model, against documentary proof of expenses. If the designer or group of designers needs to visit the minter, Eesti Pank will pay the travel and accommodation costs.
- 2.16. All the costs of participating in the design competition will be covered by the participants.
- 2.17. Designs submitted for the competition will not be returned and they will be kept permanently in the Eesti Pank museum.
- 2.18. Eesti Pank will publish the winning design and the names of the designers of the second and third-placed designs.
- 2.19. Participants submitting designs grant Eesti Pank the right to collect and process their personal data to identify the designers of the three best designs and to sign a contract with them, and to archive them in the museum in the public interest. The personal data of the competition entrants are handled in accordance with the general regulation EU 2016/679 and the Personal Data Protection Act.
- 2.20. Participants submitting designs for coins to the competition are considered to have accepted the conditions for entry of the competition.

### **3. Technical specifications of the design competition**

- 3.1. The specifications for the commemorative coin are attached in Appendix 1 of these rules and regulations.
- 3.2. The requirements for the submission of designs are:
- 1) the design must be submitted in black and white on an A4 page in two scales, 1:1 and 1:4, and raised or lowered parts must be identified;
  - 2) if the design uses reflective surfaces or matt areas, these should be shown separately;

- 3) the design can only be for the national side of the commemorative coin, the design of which is reserved to the member states;
- 4) the design for the national side must also use the circle of twelve stars around the whole national design, with the year of issue "2021" and the text "EESTI". The twelve stars must appear as they do on the standard two-euro circulation coin;
- 5) it is not necessary to repeat the name of the single currency (euro) or the nominal value of the coin on the national side;
- 6) the design around the edge of the commemorative coin is identical to that on the edge of the circulating Estonian two-euro coin;
- 7) letters and numbers should be at least 1 mm high;
- 8) in addition to the black and white designs, coloured designs and three-dimensional drawings to the same scales may be submitted.

#### **4. Assessment of the designs submitted to the design competition**

- 4.1. The designs and whether they conform with the rules is assessed by a panel convened by Eesti Pank.
- 4.2. Designs that do not conform to the terms and conditions of the design competition will be neither considered nor assessed.
- 4.3. The panel is entitled to declare that none of the submitted designs has won the competition and to declare the competition unsuccessful.
- 4.4. The three designs from among those submitted to the competition that receive the most points from the panel will be sent with proposals by the panel to the Supervisory Board of Eesti Pank to approve the winning design, after which the design will be sent for approval to the Council of the European Union.
- 4.5. The results of the competition will be announced by 30 August 2020 at the latest.

## **Rules of procedure of the panel for the competition to design a two-euro commemorative coin for the Finno-Ugric peoples**

### **1. Composition of the design competition panel**

1.1. The designs and whether they conform with the rules is assessed by a panel convened by Eesti Pank and composed of:

- A member of the Executive Board of Eesti Pank as Chair of the panel
- A member of the Supervisory Board of Eesti Pank
- A member of the Cash and Infrastructure Department of Eesti Pank
- A member of the General Secretariat of Eesti Pank
- A representative of the Estonian Artists' Association
- A representative of the Estonian Academy of Arts
- A representative of the Estonian Sculptors' Union
- A representative of the Institute of History and Archaeology of the University of Tartu
- Art Leete from the Department of Ethnology of the University of Tartu
- Jaak Prozes from the NGO Fenno-Ugria
- A representative of the Finnish Embassy
- A representative of the Hungarian Embassy
- A representative of the Russian Embassy
- A representative of the Finno-Ugric Support Group of the Riigikogu

1.2. Members of the Supervisory and Executive Boards and employees of Eesti Pank, and representatives of embassies or the Riigikogu will not be remunerated for their work on the panel. Other panel members are remunerated under authorisation agreements granting each panel member 100 (one hundred) euros, from which all legally required taxes and payments are deducted. The remuneration is paid if the panel member attends the meeting of the panel or sends a written proposal for the distribution of points to the Chair of the panel in a sealed envelope in advance of the meeting.

### **2. Assessment of the designs submitted to the design competition**

2.1. Panel members who so desire can examine the designs at least 24 hours before the agreed time when the decision will be made.

- 2.2. Each panel member is entitled to express their opinion on all the designs submitted to the design competition.
- 2.3. The panel will decide during its meeting on the order the designs will be assessed in and how they will be assessed. The Chair of the panel will decide the order in which opinions may be expressed.
- 2.4. Panel members assess the coin designs by each awarding points from 3 to 1 to the three designs they like the most.
- 2.5. The points given to each design are added up and it is noted which three designs received the most points. If two or more designs receive the same number of points, they will be ranked in order of which received the highest number of high scores, starting with the number of 3-point awards that each received.
- 2.6. The quorum of the panel is at least seven members including the Chair.
- 2.7. The panel is entitled to declare that none of the submitted designs has won the competition and to declare the competition unsuccessful.
- 2.8. The panel has the right to propose additions to the designs or changes to their proportions, but does not have the right to change the whole design.
- 2.9. The panel will take its decision on the designs to be submitted to the Supervisory Board of Eesti Pank and the proposal for the winning design by 15 May 2020 at the latest.
- 2.10. The results of the design competition will be published after the meeting of the Supervisory Board and after the approval procedures of the Council of the European Union have been followed, but not later than 30 August 2020.
- 2.11. Envelopes containing the names and details of the designers will be opened once the three best designs have been chosen.
- 2.12. Minutes are taken of the meetings of the panel. The meetings of the panel will be minuted by a member of Cash and Infrastructure Department of Eesti Pank who is not a member of the panel. The minutes of the panel meeting will be signed by the Chair of the panel and the person who took the minutes.
- 2.13. Issues not covered by these rules of procedure will be decided by the panel by consensus.
